Minister's foreword

Little Dip Conservation Park conserves a series of small freshwater lakes and contains a significant area of ruggedly beautiful coastal vegetation that provides habitat to endangered and vulnerable bird species. The park also offers a range of recreational activities and has been enjoyed by the owners of shack leases for many years.

In December 2019, the Department for Environment and Water sought the community's views about proposed changes to the management of shack leases within the park through the release of a draft amendment to the *Little Dip Conservation Park Management Plan 1992*.

All submissions received on the draft amendment have been considered and have assisted in the development of this final amendment. I thank all those that made a submission.

I am now pleased to adopt the Little Dip Conservation Park Management Plan Amendment 2020.

Managing shack site leases

There is one shack site remaining in Little Dip Conservation Park which has been leased and enjoyed for many years.

Prior to the adoption of this amendment to the park management plan, there was a life-tenure limit on shack leases within this park.

These amendments will enable Government to consider offering a longer term renewable lease for the shack site within the park.

Eligibility for a longer term renewable lease will be subject to the lessees meeting certain conditions including making any necessary upgrades to the shack in order to conform to relevant standards.

Consistent with park usage, lessees and shack visitors will be required to abide by park regulations in place to ensure the protection of park values.
