I refer to your email of 30 August in which you request the following information under the Official Information Act 1982 (OIA):

- 1. Did New Zealand send any representatives to COP 27?
- 2. Please outline which ministers attended COP 27?
- 3. How many members of staff accompanied the Minister(s) to COP 27?
  Please provide the job descriptions of those who attended.
- 4. Please provide the total travel cost involved for both staff and Minister(s).
  - Break down the travel cost further by ticket class for each attendee and the cost of travel for each attendee.
- 5. Where did the Minister(s) and staff stay while at COP 27?
  - Please breakdown the accommodation cost and outline what days and nights the party stayed.

The Ministry of Foreign Affairs and Trade (the Ministry) can only respond in relation to the Ministry's delegation. Therefore, we have interpreted your request to be for information held by this agency.

Regarding questions one and two of your request, the Minister of Climate Change represented New Zealand at COP 27. Please note that the Ministry does not hold information on travel costs for the Minister of Climate Change or other members of his office.

Regarding questions three, four and five of your request, please refer to the table below. All figures are listed in NZ Dollars (\$). Staff member one and two are based in Egypt at the New Zealand Embassy, and their cost of travel is for the fuel used to attend COP 27. The remaining staff (3-10) are New Zealand-based officials and flew on a business class ticket, consistent with the Ministry's travel on business policy.
